Mental Health Alliance



Split into different components:

- Depression annual reviews
- SMI reviews including physical health checks of SMI patients (QOF) and patients on anti-psychotic medication (not on QoF SMI register)
- Depot injections
- ADHD reviews for CYP and Adults new



Depression Reviews



Payment Indicator

Patients aged 16yrs and over with QOF depression code and on either repeat antidepressants or with more than 2 issues of antidepressant medication in last 6m (excluding patients on palliative care register) with an annual review

Note: This review can be completed either F2F or by telephone or video link.



Elements of Review



How does a review become 'Payable'?

- Review recorded
- Medication review GP or pharmacist
- Review of physical health including smoking and alcohol status GP, pharmacist, PA, PN or HCA
- Consideration of referral to social prescribing within last 2yr GP, pharmacist, PA or PN
- Consideration of psychological therapies by GP if patient not received formal psychological therapy within last 2yrs
- Review of wellbeing including giving Emotional Wellbeing leaflet if patient not received one within last 2yrs

TARGET >=36%

- Stand alone CEG Depression Review template
- CEG LTC template depression review page

Are there any personalised care adjustments (Exception coding) – on template?

 Declined to give smoking status, declines to state alcohol consumption, psychological therapy declined or not suitable, social prescribing declined, medication review declined

Where can I refer patients to Talking Therapies/Wellbeing?

City and Hackney Talking Therapies (Free) – Online referral

Consider referring patients to City and Hackney Wellbeing Service – Online referral



FAQs cont.



What is the Emotional Wellbeing Leaflet?

- Patient leaflet contains crisis numbers as well as links to Talking Therapies and Wellbeing Service.
- Link is on templates.



SMI reviews



Payment Indicators

a) Patients on QOF mental health register (excluding patients latest code is in remission) with an annual physical health check

Note: Some elements can by done by telephone but others such as BP, blood test need to be F2F.

Can be carried out by GP, HCA, nurse, PA. Med review will need to be done by GP.

b) Patients on QOF mental health (excluding patients latest code is in remission) with a care plan – PKB or mental health care plan (paper)

Note: Different payment tariffs for plan.

Elements of Physical Health Check Review



How does a review become 'Payable'? 9 elements

- BMI
- BP
- Blood lipid or QRISK
- HbA1c
- Alcohol status
- Smoking status
- Drug misuse status
- Nutritional and level of physical activity
- Medication review

TARGET >= 80%

Core Sports – referral form in documents

What is PKB?

Creation of a digital plan, known as Patient Knows Best. Accessible via phone/or PC. If PKB not available a paper plan can be used and stored on EMIS.

Depot Injections



Payment Indicator

Number of patients given a neuroleptic depot injection quarterly

£75 per depot

Use SMI review page in LTC template



ADHD Reviews



Payment Indicator

Patients with ADHD on medication in last 12m with an annual review

Template:

RP LTC Childrens or RP LTC City and Hackney

Payment: £27 per review

Note: Review – primary care encouraged to do at least an annual physical health check for patients prescribed ADHD medication in primary care. Review can be done by GP, pharmacist or ANP who feels confident to advise on ADHD medication.

Easy wins



Depression:

Patients only missing code for depression review – did practice do a review and not code.

SMI and antipsychotics

Patients only missing medication review

Depot medications:

Quality search: - On depot missing payment code

Remember to check the Appointment suite of searches – patients with an appointment booked and they are missing reviews



Protocols and zap template



Encourage clinicians to use alert box.

CEG have built alerts for when patient is missing indictors for Depression/SMI/Antipsychotic reviews.
