Further and Higher Education 2026 Statement of Recommended Practice [FIC24/42]

2024.049 The Committee **considered** an update on the Further and Higher Education 2026 Statement of Recommended Practice (SORP). Following amendments to Financial Reporting Standard 102 in March 2024, work had been underway on the development of a new SORP for Further and Higher Education. Guidance would be produced in relation to revenue recognition and leases that was likely to present challenges with students in receipt of bursaries, scholarships, studentships or stipends. Based on the University's finances it was not anticipated that there would be any impact on the University's bank covenants as there would be sufficient headroom to manage the changes.
