Next steps following the Council Conference

- 1. The Council Conference in May 2025 identified the following priorities for the University in the context of the Strategy and the changing external environment:
 - taking immediate steps to address the University's financial model (reducing the cost of education; increasing cost recovery on research; diversifying income streams) and reviewing the University's wider business model;
 - within the existing KPIs, a focus on student retention and employability;
 - consideration of the University's international strategy for education and research;
 - next steps following acquisition of the Whitechapel Road development site.
- 2. The Conference also identified partnerships, the workforce and the potential impact of AI as cross-cutting themes.
- 3. The proposed schedule of business for next year (attached) is designed to focus on the priorities identified at the Conference and maintain the same depth and openness of discussion involving a range of university leaders. Two deep dive discussions on the financial model for education and research are proposed in the autumn, leading to more forward-looking discussions on the future business model and size and shape of the University in the spring. An assurance update on progress with savings is proposed to coincide with the approval of the budget in March. The schedule also includes sessions on student retention and employability, life sciences, the international strategy, transnational education and the workforce strategy. It is proposed that Audit and Risk Committee carries out a deep dive on readiness for AI in the autumn.
- 4. In previous years, the QMSU executive team has presented informally to Council on manifesto priorities towards the end of the calendar year. Next year, it is proposed to move this presentation to January, giving an opportunity for the team also to present on delivery of the QMSU strategy and KPIs.
- 5. The Secretariat has reviewed the standard schedule of business to create more space for these strategic discussions and respond to feedback on reducing the volume of paperwork at meetings. Council is asked to endorse the following approach.
 - [a] Greater delegation of certain issues to committee level where there can be an appropriate level of scrutiny.
