2021.084	The Deputy Director of Procurement, Finance and MD have met with		
	FORS (Fleet Operator Recognition Scheme), a voluntary accreditation scheme for fleet operators which aims to raise the level of safety,		
	efficiency, and environmental protection in fleet operations, to discuss how		
	it works and the potential for its use at Queen Mary.		
	FORS are an optional accreditation that suppliers can achieve, where they		
	pay an annual membership fee and have audits carried out to determine		
	gold, silver, and bronze status (Audits are at additional cost). Following a review of the supplier base, 644 suppliers with spend over £1,000 were		
	Treview of the supplier base, off suppliers with spend over 21,000 were		

	identified who could work to achieve the FORS accreditation. Currently 3 suppliers are accredited to FORS, Bunzl – cleaning products, Bywaters – waste, BOC – gasses.
	The Deputy Director of Procurement, Finance will continue exploring relevant opportunities with FORS to see how we can support the accreditation. However, at this stage we will not impose the requirement on our supply chain due to mandatory cost and accreditations - given the challenging economic situation.

2021.086	The Head of Sustainability reported that Queen Mary has successfully achieved the EcoCampus Environmental Management System (EMS) Silver Certification Award after a full-day external environmental audit conducted on 1 April 2021.
	This full-day external environmental audit was conducted remotely. As part of this audit, the Auditor remotely met with various individuals across the University as well as some of our Environmental Associates.
	<ul> <li>The certification audit covered the following areas:</li> <li>Environmental Compliance Obligations</li> <li>Environmental Aspects and Impacts</li> <li>Environmental Policy and Strategy</li> <li>Environmental Actions in the areas of:</li> </ul>

5. Teaching and F	Research
5a.	€2 million grant to develop more efficient solar technology.
2021.087	Dr Joe Briscoe presented on his recently received ESC grant for a 5-year project to work on new approaches to solar cell technology conversion.
	The project aims to use ferroelectrics with asymmetric crystal structures to overcome efficiency thresholds of current solar technologies and as a result make solar power as cheap as possible.
	Normal solar cells convert around 30% of solar energy received into electricity with a larger amount lost as heat. The project aims to use nano structures to increase the absorbance capacity of ferroelectrics which currently only absorb UV light.
	The project also includes work on Photoelectrochemical (PEC) water splitting techniques to separate hydrogen and oxygen for use as fuel.
OUTCOME	The committee thanked Dr Briscoe for his presentation and that he will be invited to update the committee on the project's progress.
5b.	Embedding Environmental Sustainability in the Medical School Curriculum (SC.21/22)

2021.088	<ul> <li>Anna Moore and Florence Wedmore who work with the University's medical school in their roles with Barts NHS Trust presented to the committee on embedding environmental sustainability in the medical curriculum.</li> <li>They emphasised the need to integrate education for sustainable healthcare into the undergraduate medical curriculum to help the NHS as:</li> <li>Climate breakdown is already causing significant harm to human health, in the UK as well as globally</li> <li>The recent <u>NHS net zero report</u> commits the health service to net zero carbon emissions by 2040.</li> <li>Healthcare is a significant contributor to climate breakdown and air/other environmental pollution</li> <li>With its emphasis on prevention, patient empowerment and streamlined care, sustainable healthcare is good healthcare</li> <li>Sustainable healthcare education gives students opportunities to develop skills in critical and systems thinking, both vital for the roles they will play in 21<sup>st</sup> century healthcare services</li> <li>Queen Mary currently includes some teaching on sustainability although this is not compulsory or integrated into the curriculum. Good practice already includes:</li> <li>The 4th Year Global Health Week &amp; a 2-week Student-Selected component (SSC) for 10 2nd year students which received overwhelmingly positive feedback and requests from students for them to be compulsory.</li> <li>Participation in the student led planetary health scorecard in which medical schools in the UK and US are graded on their sustainability</li> </ul>

6a.	Environmental Management System Update (SC.21/23)
2021.092	The Head of Sustainability gave an update on the Environmental Management System (EMS) reporting that:

	<ul> <li>Queen Mary achieved the EcoCampus Silver Certification Award after an external audit completed on 1 April 2021.</li> <li>During the audit 1 minor non-conformity was raised regarding compliance with Waste (England and Wales) Regulations 2011 regarding our non-hazardous waste management processes. It is recommended that this be resolved by 31 May 2021.</li> <li>Additionally, 2 opportunities for improvement were identified relating to the inclusion of permits for radioactive substances and F-Gas certificates in our environmental compliance register. These have now been resolved.</li> <li>A further opportunity for improvement will be addressed through updating the wording of the Environmental Policy to reference specific ISO 14001:2015 EMS clauses when this is reviewed in October.</li> <li>Queen Mary's Gold EcoCampus audit is scheduled for 8 July 2021. The Head of Sustainability requested the support of relevant committee members to support our preparation for this audit.</li> </ul>

	recommendation that open non-conformities from the silver audit be closed by 31 May 2021 and endorsed the scheduled EcoCampus Gold certification audit scheduled for 8 July 2021.
